Old batteries, used motor oil, fluorescent bulbs, and white goods, not containing freon, such as washers, dryers and stoves must be taken to the Duplin County Landfill located at 376 Landfill Rd, Rose Hill, NC, for proper disposal.

Appliances containing freon such as refrigerators, freezers and air conditioners may be taken to the Duplin County Landfill located at 325 Landfill Rd, Rose Hill, NC.
(FREON MUST BE REMOVED)

Old batteries may also be taken during normal business hours to Turner Auto Parts located at 370 NE Center St in Faison.



Old tires may be taken to the Duplin County Landfill located at 325 Landfill Rd, Rose Hill, NC. A resident of Duplin County is allowed to dispose of tires for free.

GARBAGE & RECYCLING DAYS**

Customers paying solid waste fee will receive solid waste curbside pickup by an outside contractor.

SOLID WASTE COLLECTION

Thursdays

Garbage carts should be placed on the curb side by 7:00 a.m. **All garbage should fit inside cart with the lid closed.** Additional carts will be required if deemed necessary and customer will be billed accordingly.

HOUSEHOLD ITEMS/JUNK/PRE-TREATED WOOD COLLECTION

Fridays

Household items/junk, pre-treated wood, wood products, boards, etc., will be picked up on Fridays. **Wood cannot weigh more than 50 lbs.** Items must be on the street by 7:00 a.m

DID YOU KNOW?

North Carolina Law mandates that all corrugated cardboard boxes, aluminum cans, used motor oil, oil filters and lead acid batteries must be recycled.

The following items are also banned from NC landfills: antifreeze, appliances, oyster shells, scrap tires, yard waste, plastic bottles, wooden pallets, electronics, and ABC beverage containers.

**RESPONSIBILITIES WITH
CONTRACTORS, LANDSCAPERS,
HOUSE CLEANOUTS**

Landscaping companies and general contractors performing any yard work or construction work will be responsible for removing any waste. Contractors doing tree work are responsible for removing all tree trunks, stumps, and limbs.

**THE TOWN WILL NOT PROVIDE PICKUP SERVICE FOR HOUSE CLEANOUTS OR REMODELING PROJECTS WHETHER DONE BY CONTRACTOR OR PROPERTY OWNER.
PROPERTY OWNERS ARE RESPONSIBLE FOR ALL DISPOSAL OF THESE ITEMS.

YARD WASTE COLLECTION SCHEDULE

Tuesday

Yard waste such as grass clippings, hedge trimmings, twigs and leaves will be picked up on Tuesdays.

Brush & yard waste must be at the street by 7:00 am on the day of pickup.

Generally, limbs and tree trunks larger than 6 inches in diameter are too heavy for collection.

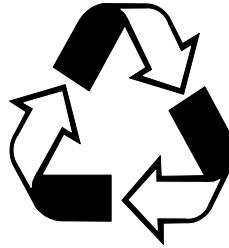
Large tree trunks and stumps will not be accepted.

Pre-treated wood, wood products, boards, etc. will be picked up with the regular household collection on Friday. Wood cannot weigh more than 50 lbs.

Schedule is subject to change due to holidays, inclement weather, and emergencies.

It shall be unlawful for any person to blow, rake, sweep, wash, direct or place any debris of any kind including, but not limited to, yard waste, grass clippings, leaves, sediment, trash and the like in any street, storm drain, ditch, culvert or any other area where it might impede the flow of water through the storm drain system of the town.
